MEMORANDUM OF UNDERSTANDING

And

Rampurhat College, Rampurhat Birbhum, West Bengal, India, UGC 1st Cycle NAAC accredited college affiliated under the University of Burdwan and Government of West Bengal aided college represented by its Teacher- in – charge Dr. Buddhadeb Mukherjee, hereinafter referred as the Second party (Which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, , administrators, and assigns) OF THE OTHER PART.

WITNESSTH THAT:

WHEREAS, Hiralal Bhakat College and Rampurhat college desire to promote the chrichment of their teaching, learning, research and discovery missions, and

WHEREAS, Hiralal Bhakat College and Rampurhat college desire to provide for a variety of collaborative opportunities for faculty and students at the two colleges on the terms and conditions hereinafter set forth.

NOW THEREFORE, it is mutually agreed as follows:

I.Scope of Agreement: This Agreement shall commemorate the parties , intent to enter into but not be limited to, the following types of collaboration:

- (a) Short and Long- term Faculty Exchange
- (b) Undergraduate Student Exchange
- (c) Collaborative Learning and Teaching, Research and Project,
- (d) Other mutually agreed educational or research programs

Before implementing these activities, the parties will discuss the opportunities and challenges presented and will thereafter enter into specific activity agreements based on the mutually agreed objectives and outcomes.

- II. Period of Agreement: This Agreement shall be effective upon the date of final execution and will remain in force for a period of THREE YEARS. Either college may terminate the agreement by providing notice to the other party in writing.
- III. Activities under This Agreement: It is expected that activities taking place under this Agreement will be initiated primarily by academic units within each college, and in coordination with their respective administrative units. Both Colleges will follow guidelines of The University of Burdwan for faculty and student exchange.
- iv. Planning and Management of Activities: Each distinct collaboration program or activity will be described in a separate Activity Agreement drawn up jointly and signed by authorized signatories of each college. Such agreements will specify the names of those individuals on each campus responsible for the implementation of the program and set forth all terms and conditions associated with the activity.
- v. Library Facilities: Library resources of both colleges can be shared, modus operandi of which will be

settled jointly by the Library departments of both the colleges.

vi. Funding of Activities: Activity Agreements should make financial costs and obligations explicit. Collaborating units are encouraged to work together to identify and secure any outside funding which may be needed.

viii. Use of Name: Both Hiralal Bhakat college and Rampurhat College will not use the name or logo of the other colleges in any publicity, advertising, or news release without the prior written approval of an authorized representative of college.

ix. Modification: The terms of this Agreement may be changed or modified only by written amendment signed by authorized agents of the parties hereto. If any disputes arise in this MOU, in that case Principal / Teacher- in-Charge of both colleges will discuss and settle the matter amicably.
